- 4. PDE 6004 Form Arrest/Conviction Report and Certification Form.
- 5. Sexual Misconduct/Abuse Disclosure Release Form pursuant to Act 168 of 2014

Crawford Central School District will maintain the right to cancel this contract at any time without penalty by giving Woodring written notice of such action if our service is unsatisfactory or is not wanted.

Woodring shall continue to maintain liability insurance and the Certificate of Insurance will name Crawford Central School District as an additional insured.

Woodring agrees to pay its employees' wages, benefits, and its share of payroll taxes as well as to provide unemployment compensation benefits and workers' compensation insurance to them. Woodring also agrees to pay for its liability and workers'
