*Please note that first year dual enrollment or other early entry students may enroll in a maximum of 6 credits during their first term of enrollment and may enroll in a maximum of 12 credits during each subsequent term of enrollment without special permission. This includes the total of all credit hours of enrollment at all post-secondary institutions of higher learning.

**Students must have a minimum cumulative GPA of 2.5 and must be granted junior standing. Transcripts must include SAT/ACT scores for NPRC to consider scores official; however, SAT/ACT scores are not required for admission.
